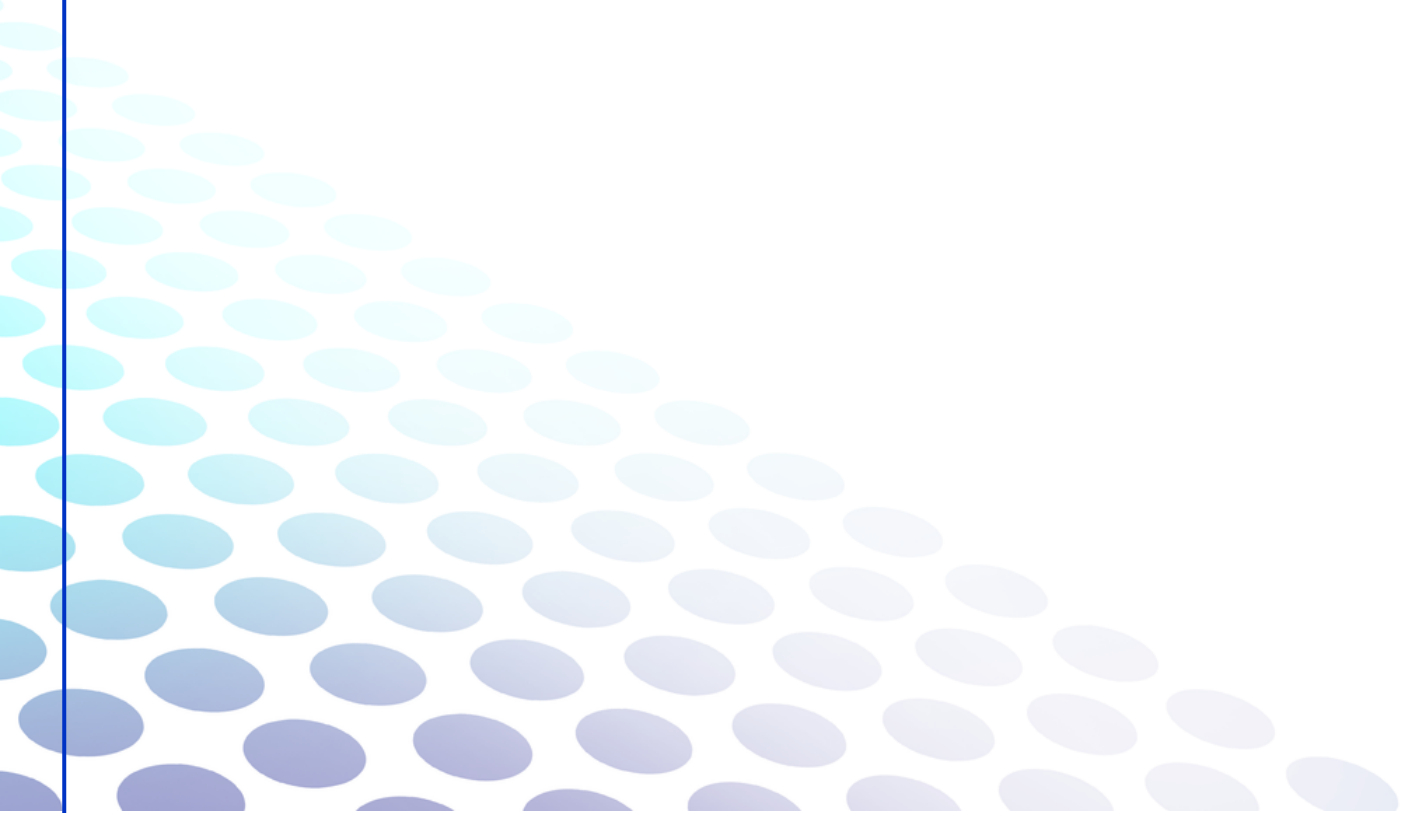

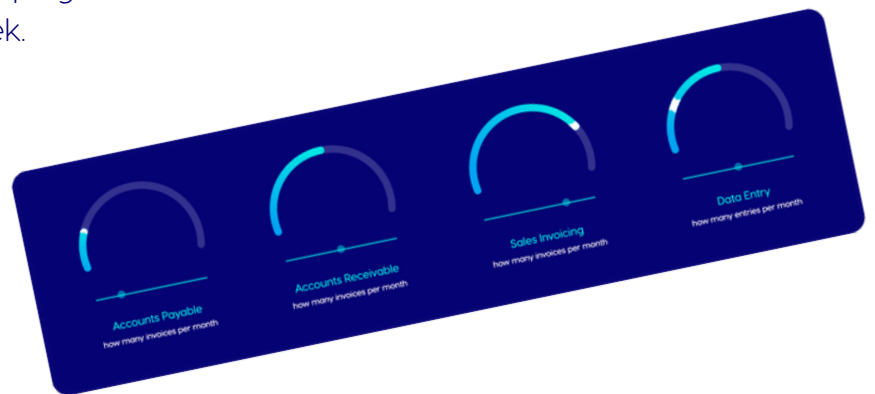
Bookkeeping

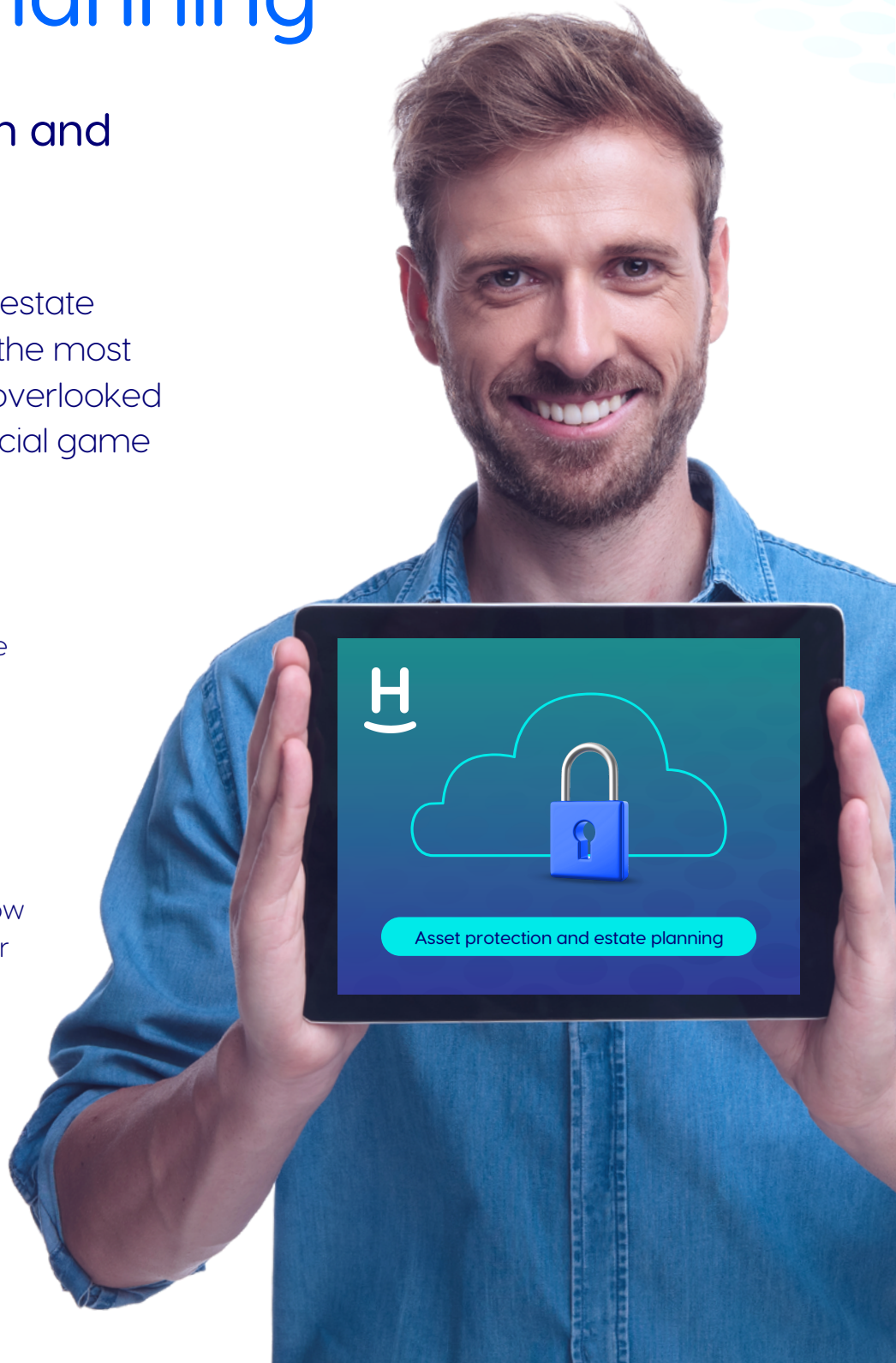

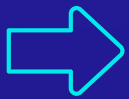
